Job Summary:

Drive Food Share vehicles (Class C) to deliver daily orders to partner agencies. Pick-up donations on an as needed basis as directed by the Warehouse Manager.

Essential Functions:

- Drive Food Share's Class C vehicles.
- Project a positive public image of Food Share at all times.
- Perform deliveries to partner agencies.
- Perform pick-ups from donors.
- Accurately process delivery and donation paperwork.
- Responsible for cleanliness of truck.
- Report any truck issues / concerns to Supervisor.
- Food Safety awareness.
- Other duties as assigned.

Other Duties:

- Assist with warehouse activities when driving and vehicle maintenance duties are complete.
- Report vehicle maintenance issues to the router.
- Assumes additional responsibilities as requested by the Warehouse Manager, Operations Manager or the President if the previous named managers are absent.

Job Qualifications:

- Two or more years of delivery driving experience.
- CA Driver's License and Clean DMV record required.
- Willing to work flexible schedule determined by food needs of the food bank.
- Bi-lingual Spanish/English preferred.
- Able to pass health screening and background check.

Skills and Abilities:

- Knowledge and experience of vehicle maintenance.
- Ability to tow 29' trailer with Food Share Truck
- Ability to communicate well with staff and Food Share customers.
- Ability to communicate with volunteers and receive vehicle maintenance updates and reports.
- Able to function within an environment requiring multi-tasking skills.
- Ability to maintain a positive attitude
- Ability to operate forklift and other warehouse equipment.

Departmental Requirements:

- All Drivers are required to be organized and efficient at prioritizing projects
- All Drivers need to have the ability to work with and manage volunteers to maximize efficiency
- All Drivers needs to have exemplary customer service skills to communicate with all food bank stakeholders
- All Drivers needs to ensure they follow Food Safety Standards throughout the organization.

Physical Requirements:

- Lifting (up to 50 lbs.).
- Able to sit or stand for extended periods of time.
